The tender document should be signed by the authorized signatory with name & seal of the firm at the bottom of all pages. Jobs have to be carried out strictly as per instruction of Route supervisor/his representative. Jobs have to be completed within the schedule time. Payment to the Contractor shall be made once in a month on submission of bill in triplicate. No payment shall be released if work performance is unsatisfactory. Labourers deployed should maintain strict discipline as per rules in the duty site. #### BETWEEN

**THE BALASORE BHADRAK DISTRICT CO-OPERATIVE MILK PRODUCERS' UNION LTD.(BBAMUL),** Balasore-756003 a society registered under the co-operative societies Act.1962 (which expression shall unless repugnant to the context or meaning thereof, include its successors) of the onepart.

And

------, herein after referred to as "the Contractor" (which expression shall, unless repugnant to the context or meaning thereof, include their successors in interest and assigns) of the other part.

Whereas BBAMUL, engaged in the business of Milk Procurement from various Bulk Milk Cooler by Milk Tankers has decided to engage Driver, helper and other labour on man-days basis through experienced contractors, having valid labour license, for carrying out its business at different places.

And whereas the contractor, who is in the business of supplying labour for various jobs and having valid license for such purpose, has submitted his offer rates to look after Driver, Helper and other Labour arrangement on man days basis as applicable at Balasore Bhadrak Dist. Co-op Milk producer's Union Ltd. Office.

Whereas, in consideration of the offer of the contractor, BBAMUL has decided to entrust the labour engagement on man days basis on the terms & conditions herein after contained.

- 1. The agreement is made for a period of one year with effect from **01.04.2021 to 31.03.22** with an option for further renewal of the same from time to time as per discretion of BBAMUL on the same or similar terms and conditions or modified terms and conditions as may be stipulated.
- 2. The contractor will supply all labour viz: Driver, Helper and other necessary workers required for office work to the authority of BBAMUL provided that the requisition thereof is made 7 days in advance.
- 3. The contractor will collect the Bio-data along with testimonials from labourer. Valid Driving license from any RTO of Govt. of Odisha is mandatory for all Drivers. The contractor will be liable in any legal matter of labourer.
- 4. The Labour contractor shall have to furnish the list of labourers along with the detail address & Contact No.
- 5. The charges as indicated in the schedule include minimum wages prescribed by the State Govt. The calculation statement of wages is given below.

P.F., ESI, Off day salary, Service charge and GST will be released on monthly Basis but Bonus & Leave salary, will be released at the end of the year after getting the receipt statement of labourer on Basic Wages or as applicable at that time.

6. Rate of wages and other statutory dues shall be changed time to time as per the revision of minimum wages by Govt. of Odisha.

7. The contractor shall have to make payment to the Bank account of labour engaged by 7<sup>th</sup> day of every successive month as per statutory requirements. The payment to the labourer engaged by the contractor should not fall short of minimum wages prescribed by the state Govt.It will not be taken into consideration by BBAMUL.

8. The Contractors shall have to produce all the supporting payment documents and photo copies of all challans in respect of deposit towards PF, ESI, GST and other statutory dues of previous month of billing period for realisation of service charges in time as per the agreement.

- 9. The work assigned to contract labour shall be completed in specific time. No work shall be kept pending. In case contractor fails to complete the work in time , any loss or damage arising out of non completion of work and engagement of other arrangements , if any , shall be recovered from the contractor under this contract as a debt payable by the contractor . If contractor fails to report for work for supply of the labour as per the work order. BBAMUL will deduct the sum as determined by General Manager as penalty from contractor's bill / security deposit and shall terminate the contract with the contractor on any such further repetition of default.
- 10. The Contractor shall comply with all the statutory requirements under various acts and rules as applicable to the establishment of BBAMUL, where the labour engagement entrusted to the contractor. In the event of non-compliance the statutory requirements like deposit of PF, ESI and GST, the payment of service charges shall be held up without any notice till necessary compliance made by the contractor however liability of BBAMUL, if any on account of such non-compliance of the statutory provisions, shall be chargeable to the account of the contractor and shall be deducted from the pending bills.
- 11. The Contractor shall not be allowed to engage labour to work more than the prescribed working hours, eight hours/day and forty eight hours in a week. However under certain compelling circumstances like sickness of any labour on duty or proceeding on leave on compassionate ground only or as situation requires permission may be granted by BBAMUL or on its behalf by the unit head or authorized officer. If the driver is engaged in a job more than 8

hours, the extra wages will be entertained as per the certification of concerned route i/c in Wages card.

- 12. in case of any accident the compensation as levied upon by the competent authority under workmen compensation Act., shall have to be paid by the labour contractor, to the legal heir of the deceased or the person concerned in case of partial or total disablement.
- 13. The contractor is required to provide welfare & health facilities to the Contract labour through ESI Dept. . All the statutory obligations as per C.L. (R&A) Act. 1970 and its Odisha rules 1975 and other labour acts and rules applicable to the contractor labourers are observed rigidly. For any irregularity in compliance of legal provision, he will be held solely responsible.
- 14. The contractor will also ensure that labour remain detached from the influence of local antisocial elements and do not indulge in any political or union activities.
- 15. The contractor shall finalize the actual deployment of labour in different period on the basis of availability of jobs in consultation with the concerned unit heads of BBAMUL or his authorized representative or such other authorized officer. The BBAMUL shall not responsible to provide any work to the labourers if the unit remains closed due to the reason beyond control or labourer not required due to less procurement of Milk or any change of Tanker Movement at particular unit.
- 16. The contractor should deploy personnel fee from any police case and furnish the names and antecedents of labourers at the time of deployment. All the deployed labourers should provided with photo identity card and should have PF and ESI number.
- 17. General Manager shall have the right to engage any labour for a particular job arising out of necessity which could not be supplied by the contractor. In that case the contractor shall ensure that the labour is included in its list & shall be deemed to have been arranged by the contractor.
- 18. The labour contractor shall make good losses sustained by BBAMUL attributable to the negligence or as result of theft/pilferage committed by the labour engaged by him. In event of theft or pilferage or untoward incident, the matter shall be reported to the police immediately. The Contractor regularly pursue the matter with police authority in event of an complaint FIR lodged with the police authority and report the status of the case to BBAMUL from time to time.
- 19. The contractor shall obey in rules regulation framed & office order issued from time to time by either BBAMUL or representative unit heads from time to time & maintain strict discipline inside the plant premises.
- 20. The labour provided by the contractor shall remain discipline inside, the campus and shall not work under influence of alcohol or prohibited drugs and shall behave in a decent manner to BBAMUL staffs, officers and visitors as well.

- 21. The agreement can be terminated by the first party during the agreement period without notice, if the performance of the contractor shall however, not leave the labour arrangement s/ deployment either during the agreement period or after the period of agreement till alternate agreement is made by BBAMUL, In no case, this period shall exceed three months.
- 22. The contractor shall at his own expenses return/handover the possession of materials at thereof materials at their disposal to the concerned unit head of BBAMUL or auhorised representative in a peaceful manner after termination of agreement.
- 23. The contractor shall deposit Rs. 50000/ with BBAMUL as security deposit. If any loss arises due to negligence of contractor, BBAMUL shall deduct such amount from the security deposit of contractor.
- 24. in the event of either party failing to act in accordance with the provision of the agreement , the aggrieved party shall at the first instance try to settle the dispute mutually and amicably.
