

## GENERAL TERMS & CONDITIONS OF TENDER

01. The tender shall be sealed and addressed to The General Manager, the Balasore Bhadrak Dist. Coop. Milk Producers' Union Ltd. Indicating the tender reference and date of the tender. The rate should be filled in the space provided in the application format of tender paper.
02. Any change in the address of the tenderer has to forthwith be intimated to the General Manager.
03. The selected bidder shall deposit Rs.5000/- in shape of DD in favour of **"The Balasore Bhadrak District Co-operative Milk Producers' Union Ltd."** Payable at Balasore towards security deposit after getting the offer letter.
04. Any correction /overwriting, if any made in the tender must be initialed by him prior to submission.
05. The Union reserves the right to finalize the contract on negotiation of rate with the tenderer / authorized representative.
06. A declaration must have to be submitted by the tenderer that he is well equipped with man and machine for carrying out the job.
07. The travel agencies /Vehicle owners must not be criminally convicted for moral turpitude. If they are found so, later on, their agreement shall be cancelled.
08. Tenderer not furnishing the full particulars, as mentioned above or as called for or not complying with any conditions set forth is liable for rejection.
09. Security deposit will be refunded to the party within 180 days from the date of expiry of the agreement.
10. On finalization of the tender, the successful bidder must enter into an agreement with the union on a non judicial stamp paper worth Rs.40/- (Rupees forty only) in order to give effect to the contract for a period of one year.
11. The coverage of duty time in a day may be more/less than 12 hours.



12. For forfeiture of Security deposit – The General Manager reserves the right to forfeit the security deposit in case the contractor violates the terms and conditions of the agreement or misconduct of the contractor/his representative.
13. The decision of the General Manager of the Union in each & every respect shall be final and binding upon the contractor. The General Manager reserves the right to reject any or all tender papers received at his end without assigning any reason thereof.
14. The tender shall submit whether proprietor or partnership firms with details of partner along with address as the case may be.
15. Xerox copies of Income Tax and sales tax clearance certificate if any to be submitted. Submission of GSTIN/ I.T.PAN is mandatory.
16. If the transporter wants to discontinue the engagement of Bolero, he is to give minimum one month notice to the Unit head of the concerned unit as well as Head Office.
17. The union reserves the right to extend the contract for further period or to terminate the contract before contractual period at the discretion of the union without assigning any reason thereof.
18. The transporter must ply the type of the vehicle as finalized in the tender. Under any circumstances, if the transporter provides smaller vehicle than the approved one, the rate of payment shall not be the same as approved rate of tender. It shall be decided by the office taking into account the type of vehicle, approved fuel consumption etc. and the transporter is bound to accept and claim the bill as per the revised rate.
19. The documents related to Vehicle like registration certificate, comprehensive insurance policy, fitness certificate etc Xerox copies are required to be submitted along with tender.
